Rochester Rep Report >>> Steve Cardell

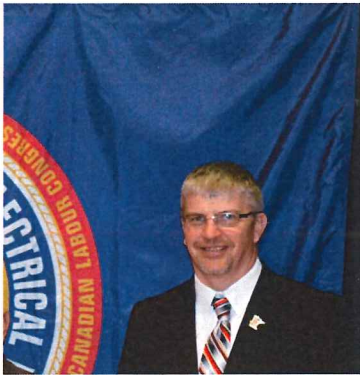

Cybex Expansion (Muska Electric) Armory Project (Russ Nelson) Viracon Expansion (Neitz/Egan) **Mankato/Western Areas:** It was a very busy spring with a lot of projects coming up for bid from Mankato-Marshall, a lot of these projects were school bond referendums. As of right now the bidding has slowed down a little bit but expect it to hold steady. Compliance Officer Report...

Prevailing Wage / Davis-Bacon  
Prevailing wage laws require that construction workers be paid wages and benefits that are found to be "prevailing" for similar work in or near the area of the project that is to be completed. These laws were passed as a means of improving labor conditions across the states. The first prevailing wage law was passed in Kansas in 1891. Minnesota passed their law in 1973. Prevailing wage applies to construction projects that are financed in whole or part by state funds.

The Davis-Bacon Act is a federal "prevailing wage" law. It was passed in 1931 during the Great Depression to combat the use of out-of-state workers undercutting local wages. The act is named after its sponsors, James J. Davis, a senator from Pennsylvania, and Representative Robert L. Bacon from New York. This bill was prompted as workers from Alabama were brought to New York to complete a construction project. Concerns over worker conditions, displacement of local workers and the pressure to pay low wages are why Representative Bacon introduced the first bill in 1927. After numerous attempts to pass this into law, Senator Davis sponsored a bill which was passed on March 3, 1931. The Davis-Bacon Act covers projects that are federally funded.

Projects with either the prevailing wage or Davis Bacon Acts attached to them require contractors to complete Certified Payroll Reports (CPR's). The reports document the classifications of the employee, the hours worked, rate of pay and deductions. These reports are subject to the open records law, which allow us access to them creating a great enforcement tool. We review the reports in depth to look for inconsistencies or inaccuracies. CPR's have been utilized in the past in Local 343 for enforcement, and currently do, as we actively pursue these projects.

The Republicans in the state legislature were talking about “Right to Work” legislation and constitutional amendments. Then in the 2012 election Democrats won majorities in both chambers.

Besides passing the “Responsible Contracting Bill” and the “Minimum Wage Bill. both of which were backed by the Unions. They also passed a large bonding bill which included 4 large jobs in our jurisdiction that our members are still working on. Those projects are:

- Rochester Civic Center expansion and renovation \$35 million
- Mankato Civic Center expansion and renovation \$14.5 million
- Minnesota Security Hospital \$56.4 million
- Minnesota State University \$25.8 million

Then came the 2014 election and Democrats lost the state house to Republicans. Let’s take a look at what happened in the last legislative session. Basically nothing.
