

The Louise Solar Project and Fillmore County Solar Projects are ramping up and are taking advantage of the favorable weather that we are having. I have attended multiple Mayo Clinic upcoming project meetings. There has been a lot of discussion on the upcoming projects that are projected to happen in the near future. There has been a lot of reports from contractors and workers on the Mayo campus about the increase in workload in Downtown Rochester. Everything is pointing to a busy Summer.

With the increase in workload in the Local, the hall also has been met with many challenges. There has been an increased effort to try and fill the open calls that we have had. I have been attending many meetings, receiving phone calls, and making job site visits as I am able to. I am also working on area informational meetings for Limited Energy members. The purpose of these meetings is to prepare for the upcoming Limited Energy Contract Negotiations. As part of Building and Trades we spent a day at Caledonia High School educating students on the benefits of joining the Unions. It was a very positive event and worth attending.

Jeff Fields and I also sat down with FCF to go over prevailing wage survey reporting. Some of my job site visits are Louise Solar site in Adams (Egan), Copperfield Terrace Event Center Plainview (H.G.), New Fire Station Kasson (BLK), New Cub Foods Rochester (Hunt)(Collins), Winona Scale (Bauer Electrotech). Some of the jobs awarded are 60 Main Apartments and Hotel (Winona) (Key), Flats on Felty 105 unit apartment building, 69 unit apartment building, 60 unit apartment building, and new club house Rochester (Accord), 1st and 3rd apartments Austin (Fox), Marion Hall 2nd floor remodel (Premier, Foster), Remodel Procedure Rooms (Mayo) (Egan), O.R. remodel Stryker equipment replacement (Mayo) (Egan), Tenant build out of Lab space (Mayo) (Parsons), 41st street professional building west, HR relocation (Mayo) (Adair), Mayo support center North, IT relocation (Adair), just to name a few. With such a promising summer ahead of us let's try to remember what it means to be part of the IBEW LOCAL 343 UNION, and our responsibility to not only welcome but also educate new members, young or old.

Brothers and Sisters,

I hope everyone is doing well and had a great start to the year. The warm weather has brought us good news, as many projects have started earlier than expected.

In January, IBEW 343 helped to cook and serve breakfast for the 2024 Eagles Cancer Telethon. Despite the bitterly cold weather, we managed to raise almost two thousand dollars. Thank you to everyone who helped!

In February, I had the opportunity to attend a week-long course at The School for Workers in Madison, Wisconsin. The course focused on labor law, effective communication, and organizing strategies. I gained valuable knowledge that will help me do my job better.

This year more than 400 million dollars of prevailing wage work has been put out for bid. I'm tracking all the ongoing prevailing wage jobs in our jurisdiction, which entails on-site monitoring and reviewing certified payrolls.

I referred two contractors to the Fair Contracting Foundation (FCF) for failing to directly supervise unlicensed electricians and misclassifying employees. These cases have been or will be filed with the appropriate state agencies.

As the Awards Banquet approaches, I look forward to seeing everyone there. As always, our members are the eyes and ears of the local, so please don't hesitate to contact me with any questions or information via phone, text, or email.

Another winter is behind us and with spring comes a new construction season. There are some contractors that will have calls coming soon: DeWar, Muska, and River City, to name a few, that have projects starting shortly.

This coming year will be a very busy and important one as far as politics go. Starting with precinct caucuses that we attended at the beginning of March, then the local county DFL convention the first weekend in April. The Day on the Hill March 26th where all the MN IBEW locals meet up with the politicians from your district. With around sixty 343 members volunteering, it's a great opportunity to meet your local representative and tour the state capital. The State of Union speech was on earlier in March

and the President again mentioned the IBEW. That's the second time President Biden has mentioned the IBEW in his State of the Union speech. So, you know whose side he's on with our members. Local 343 will not tell you who to vote for, so do your own research on which candidate has on your beliefs and the construction industry.

The work picture in the western area is looking good with some good-sized projects coming soon. Organizing Department Report by Charlie Cardell

Brothers and Sisters,

Although this winter hasn't really felt like much of one, we are closing in on spring really fast! It seemed like work didn't slow down like we usually see in the winter months this year because of it. I have been able to stay busy the last few months with the work in the eastern area that has been going strong and it sure isn't looking like it is going to be slowing down anytime soon!

In the last few months, we have brought in a few more journeymen and apprentices into our local. This has been helpful to keeping the open calls to a minimal as possible. Since taking this job we haven't seen the work picture like it is looking now with the high demand for workers like it has been and what is to come. It excites me looking at the opportunity ahead to get in front of unrepresented workers and having multiple work opportunities just waiting for them. We have started some advertising and marketing drives to continue

to get the word out to workers in the area. This so far has been helpful, and we have received some calls from it. We will continue to work forward to keep the calls filled doing whatever we can.

In January, 343 hosted a statewide blitz on contractors in our far western part of the jurisdiction. We have had some workers that had come available out in that area so we stopped at 72 contractor shops letting them know what we can offer and that there is manpower right there waiting to go to work. We had good luck with that, we ended up getting a couple follow up meetings from it that are groundwork for the future relationship.

Lastly, I will leave you with this. We have a huge task ahead of us with the work coming. I don't want to look at it as a task but more as an opportunity. I need YOUR help in this as we move forward. If you know any electrician in our area that isn't currently working under our CBA, please send their information to me or talk to them on behalf of the union.

If we can't man the work, we will lose the work!

RETIREMENT QUESTIONS & ANSWERS: – by Bonnie Hinkle

NEBF

Starting January 2025, NEBF will increase from \$32.00 per work credit to \$33.00, for new retirees.

NEBF – RETURN TO WORK

In response to a shortage of electrical workers in certain areas of the country, the Trustees of the National Electrical Benefit Fund (NEBF) and the National Employees Benefit Board have again approved a temporary Return to Work Amendment to the Plan of Benefits for the NEBF for the <u>calendar year 2024</u>. This amendment permits certain eligible retirees to return to NEBF covered and contributory employment for a period of time without a loss of pension benefits from the NEBF. Disability pensioners are not eligible (the existing rules applicable to disabled pensioners remain in effect).

All normal and early retirees with a **pension effective date of December 2023 or earlier** will be permitted to return to covered and contributory employment only and will be permitted to work for up to 600 hours during the above period without a loss of NEBF benefits. This amendment applies only to the NEBF Plan.

There is a form to be completed on the NEBF website under Recent News and sent to NEBF.

Also, you will need to start paying member dues again while you are working and the IBEW Pension will be put on hold.

"A" MEMBERS – IBEW DEATH BENEFIT

An "A" member after six (6) months of continuous and active good standing will have a death benefit in the amount of \$6,250.00 or accidental death benefit in the amount of \$12,500.00. However, no death benefit shall be payable upon the death of a non-retired "A" member if such member was more than two (2) months in arrears in dues payments, unless it can be demonstrated that the arrearage was not the fault of the member, in which case the death benefit will be reduced by the amount of the arrearage.

If an "A" member dies after retirement, the death benefit amount will be the \$6,250.00, less the pension payments made to the member, but the benefit will never be less than \$3,000.00. The accidental part of the death benefit goes away after an "A" member's retirement.

Beneficiaries:"A" members may name a beneficiary or beneficiaries to receive the death benefit. If the member fails to name a beneficiary or the beneficiary is deceased or unable to accept the benefit, the death benefit shall be payable to the following individual(s), in the indicated order of priority: 1) member's spouse; 2) member's children; 3) member's parents; and 4) member's estate.

The August 2023 issue of *The Electrical Worker* has a lot of valuable information to be considered when voting in 2024.

International President Kenneth W. Cooper and International Secretary-Treasurer Paul A. Noble wrote in the August 2023 issue of *The Electrical Worker*:

"We know that for many members, politics and the particulars that go into legislation and policymaking are the last thing they want to hear about.

Partisanship and division are at an all-time high, with the loudest and most extreme voices in the mainstream media and online getting the most attention.

So, it's no surprise that some of you would rather tune out.

But while you might ignore politics, politics won't ignore you. This is something we have both learned over the course of our long IBEW careers.

It is a lesson that generations of IBEW and other union members have learned ever since the dawn of North America's labor movement."

Dear Brothers and Sisters,


Well after a winter that never was, and spring-like weather for the last month or so, the calendar shows an "official" start of spring is just around the corner!

The Delegates of the 40th IBEW International Convention, which was conducted in Chicago, Illinois, during the week of May 9 through 13, 2022, approved several amendments to Article IX of the *IBEW Constitution*. Accordingly, effective January 1, 2023, there will be an increase of two dollars (\$2.00) for the per capita that is paid to the General Fund only. There will also be an increase of two dollars (\$2.00) in the IBEW Pension Benefit Fund (PBF) contribution, which applies to "A" members only. The following rates will apply to the international office portion of all monthly dues payments for January 2023, and thereafter:

In accordance with Article IX of the *IBEW Constitution*, \$22.00 per month from each member will be deposited in the General Fund, and the additional amount paid by "A" members (\$21.00 per month) will be deposited into the IBEW Pension Benefit Fund.

arrangements to update their software to ensure that the most current version of the LaborPower Express software package is installed. It will not be necessary to amend the local union bylaws with respect to this dues increase, because these changes were approved at the IBEW International Convention.

The payment of monthly per capita and Pension Benefit Fund (PBF) contributions to the International Brotherhood of Electrical Workers is a duty that is required of each individual member. Moreover, each financial secretary is responsible for collecting and forwarding all per capita and PBF payments to the international office in a timely manner.


